

Per Pupil Spending by District?

The annual amount of district expenses divided by the number of pupils for fiscal 2010. – Fairfield City Schools is 41st out of the regions 49 districts. Ohio adjusts what it pays for public education by how much it assumes districts will raise from property taxes. Each district gets differing amounts from the state and sets their own local school tax rates. Some districts also impose a school income tax rate rate. And every district except Cincinnati is allied with a joint vocational school system that also collects a school tax. This chart compares school taxes in each Cincinnati-area district by calculating the taxes on a \$100,000 home.

Net Tax on a \$100,000 home: Considers property tax rate, but subtracts rollbacks and homestead reductions. In nine local districts that also wage an income tax for schools, that figure has been converted to an amount equivalent to the local property tax and added.

State Paid per Pupil: The annual amount of state funding per pupil sent to each school district in fiscal 2010.

District Spent per Pupil: The annual amount of district expenses divided by the number of pupils for fiscal 2010.

2011 State Rating: Ohio's state rating system on school report cards uses six designations, from highest to lowest: Excellent with Distinction, Excellent, Effective, Continuous Improvement, Academic Watch and Academic Emergency. The rating is based on student scores on state tests, graduation and attendance rates, and on progress toward federal and state academic goals.

Average Taxable Income: Derived from income tax data filed with Ohio in 2009 for 2008 earnings

Local Tax Effort Index: Looks at local school taxes paid by residents in the context of their ability to pay, as measured by median income levels, and compared to a similar statewide figure.
